6. No religious, political themes or nudes will be accepted. Work done in a workshop may be eligible for entry only if the subject matter and reference material is that of the artist.

7. Work must remain for the entire length of the show. In the event a painting is sold, the artist should contact the Exhibit Committee Chair to arrange for removal and a suitable replacement of similar size submitted.

8. Artwork must be exhibited one time only at each venue.

9. In the event that a theme is announced for a show, an artist's work must reflect the theme to qualify for 1<sup>st</sup>, 2<sup>nd</sup>, and 3<sup>rd</sup> prize.

Exhibit Committee Chair reserves the right to decline an entry into a specific show for failure to follow the stated rules.
